RESOLUTION NO. 2013-12

A RESOLUTION REQUESTING THE HONORABLE RODOLFO P. DEL ROSARIO, GOVERNOR OF THE PROVINCE OF DAVAO DEL NORTE TO EXTEND ASSISTANCE BY ALLOCATING FUNDS FOR THE REHABILITATION OF DAMAGED DIKES ALONG THE RIVERS SITUATED IN BARANGAYS TANGLAW AND MAGUPISING, THIS MUNICIPALITY.

WHEREAS, Barangays of Tanglaw and Magupising are among the municipality's low lying areas wherein flooding is so frequent both being too close to a river which gets easily swollen every time heavy rains occur.

WHEREAS, the situation of these two barangays has worsened because a larger portion of the dikes that used to protect the area had been scoured and washed away by raging waters when super typhoon Pablo took place last month and followed by another flooding just recently;

WHEREAS, this Local Government Unit's very limited finances could not warrant the cost of rehabilitation of the said dikes, and help from other sources is deem urgent and extremely necessary to avoid further damage of the structure and danger for all the inhabitants;

WHEREFORE, on motion of Hon. Allan S. Paraguya and duly seconded by all members present, it is hereby

RESOLVED TO REQUEST AS THIS BODY HEREBY REQUESTS THE HONORABLE RODOLFO P. DEL ROSARIO, GOVERNOR OF THE PROVINCE OF DAVAO DEL NORTE TO EXTEND ASSISTANCE BY ALLOCATING FUNDS FOR THE REHABILITATION OF DAMAGED DIKES ALONG THE RIVERS SITUATED IN BARANGAYS TANGLAW AND MAGUPISING, THIS MUNICIPALITY.
