RESOLUTION NO. 2011-41

A RESOLUTION REQUESTING THE HONORABLE SENATOR FERDINAND R. MARCOS, JR. TO GIVE FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, IN THE AMOUNT OF TWO MILLION PESOS (P 2,000,000.00) TO BE USED TO FUND COST OF DEVELOPMENT OF THE 2-HECTARE LOT INTENDED FOR THE LOW COST HOUSING PROJECT FOR LOCAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT.

WHEREAS, it has been quite some time now that this Local Government Unit has acquired a 2-hectare lot it intends to develop for its low cost housing project for local officials and employees, but then the said lot has remained undeveloped until now because funding for this project is inadequate;

WHEREAS, this local government took many attempts to solicit funding support from other national agencies and officials but sadly to say that those efforts unluckily fell on deaf ears;

WHEREAS, this project is deemed a priority of the local government since majority of its officials and employees do not have a house and lot of their own, while some live in other localities. The materialization of this project will be in pursuance to a certain provision of the Local Government Code as well as in compliance to a localization policy of the present administration;

WHEREFORE, it is for these reasons that this body is seeking financial assistance from the good Senator whose generosity and compassion for the needy is beyond reproach;

WHEREFORE, on motion of Hon. Julian J. Dujali, Jr. and duly seconded by all members present, it is hereby

RESOLVED TO REQUEST AS THIS BODY HEREBY REQUESTS THE HONORABLE SENATOR FERDINAND R. MARCOS, JR. TO GIVE FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF BRAULIO E. DUJALI IN DAVAO DEL NORTE , IN THE AMOUNT OF TWO MILLION PESOS (P 2,000,000.00) TO BE USED TO FUND COST OF DEVELOPMENT OF THE 2-HECTARE LOT INTENDED FOR THE LOW COST HOUSING PROJECT FOR LOCAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT.
