**RESOLUTION NO. 2011-50**

**A RESOLUTION REQUESTING THE HONORABLE GOVERNOR RODOLFO P. DEL ROSARIO TO GIVE FINANCIAL ASSISTANCE TO THE MUNICIPALITY OF BRAULIO E. DUJALI IN THE AMOUNT OF TWO MILLION PESOS ( P2,000,000.00) TO BE COVER COST OF CLEARING ACTIVITIES AT HEAVILY SILTED PORTIONS OF PAWAS AND MAG CREEKS AS WELL AS FOR THE REHABILITATION OF PROTECTION DIKE AT SITIO PAWAS.**

**WHEREAS**, the onset of rainy seasons that brought flood just recently had placed almost the entire municipality underwater again and damage to rice farms, banana plantations, livestock, government structures had reached to millions of pesos thereby sending poor constituents and government people alike in extreme miseries;

**WHEREAS**, Pawas and Mag Creeks are currently heavily silted hence, both can no longer accommodate large volume of waters coming from upper tributaries and Pawas protection dike obliterated thereby resulted to overflowing of water to nearby farms and later submerging even households in most parts of the municipality;

**WHEREAS**, this body is anxious about another flooding to happen because it rains almost every afternoon and now waters in these creeks had noticeably elevated, unless immediate clearing activities and rehabilitation of protection dike will be done;

**WHEREFORE**, on motion of Hon. Romulo S. Esmino, Jr. and duly seconded by Hon. Restie E. Tabirao; Hon. Julian J. Dujali, Jr.; Hon. Allan S. Paraguya and Hon. Marcelino O. Facula, it is hereby
