ARAÑAS, MPA, PROVINCIAL MANAGER- NFA DAVAO DEL NORTE, IN CONNECTION WITH THE DESIRE OF THE MUNICIPALITY OF BRAULIO E. DUJALI TO AVAIL OF A CREDIT LINE WITH THE NATIONAL FOOD AUTHORITY.

WHEREAS, flooding is seem to be a regular phenomenon in the Municipality of Braulio E. Dujali. The calamity strikes every year and one of the worst case scenarios was the recent when too many banana plantations, rice farms , livestock and primary government infrastructure and projects were washed away and households immersed by raging waters, sending several poor families to extremely pathetic condition;

WHEREAS, the local government always reserves an allocation for times such as these but then the processing of documents needed in the procurement of food for ration to affected families , more often than not takes time thereby distribution becomes delayed;

WHEREAS, the local government has now come to realize that to avail of a credit line with the NFA is the most possible remedy to extend quick response to needy constituents , because should a calamity suddenly strikes, the local government could get adequate supply of rice at once, at a very affordable price;
