A RESOLUTION REQUESTING THE DEPARTMENT OF HEALTH REGIONAL OFFICE X1- DAVAO CITY TO EXTEND FINANCIAL ASSISTANCE FOR THE SUSTENANCE, MEDICATION AND CHEMOTHERAPY OF MRS. CORAZON CARNO AND MRS. NEMIA EGAY, BOTH ARE BARANGAY HEALTH WORKERS OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, the two ladies mentioned in the foregoing are long time Barangay Health Workers of this municipality. Even before the creation of Braulio E. Dujali until the time that their respective illnesses rendered them incapacitated, Ms. Carno and Ms. Egay, who , without asking for any compensation, spent most of their precious times serving and taking care of countless of poor and ailing constituents;

WHEREAS, they could have shun away from the pressures of work, could have stayed and enjoyed with their own families at home but perhaps, it was in public service that they had found the true meaning of joy and fulfillment, yet, life was so harsh that amidst their great desire to continue serving their people, a debilitating ailment struck, leaving them both too sick, pitiful and helpless;

WHEREAS, recently Ms. Carno suffered a stroke and had half her body paralyzed, while Ms. Egay was diagnosed as having Invasive Ductal Cancer Left with bone metastasis Stage IV and currently undergoing adjuvant chemotherapy and bone treatment for 6 cycles;

WHEREAS, everybody in the community knew that their individual families indeed, cannot afford the expensive medication considering the fact farming is their only source living. Their deplorable situation is aggravated when a calamity hit the locality, spared almost no farm, including theirs;

WHEREAS, it is for this reason that this body had proposed to seek assistance from other government officials and agencies, if only in that way, this assistance could bring them back to a longer, livelier, and a happier life with their loved ones;
