### RESOLUTION NO. 2011-80

A RESOLUTION REQUESTING ENGR. FELIX M. RAZO, REGIONAL IRRIGAION MANAGER, NATIONAL IRRIGATION ADMINISTRATION (NIA) REGION XI, DAVAO CITY TO GIVE PERMISSION TO THE LOCAL GOVERNMENT UNIT OF BRAULIO E. DUJALI AND BARANGAY TANGLAW TO CHIP OFF THE UPPER PORTION OF A DAM SITUATED AT PUROK 2, TANGLAW, BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, this Sangguniang Bayan received a resolution coming from Barangay Tanglaw, requesting the Local Government Unit of Braulio E. Dujali for the immediate demolition of a dam situated at Purok 2 of said barangay, because according to them the dam had greatly contributed to the flooding incident that took place recently, wherein the water was chest deep high;

WHEREAS, according to affected families, the dam used to catch not just water from tributaries but also debris, like banana trunks, grasses and tree branches. All these rubbish got stacked at the passageway then water becomes obstructed and large volume of it will flow backwards spilling over to rice fields, plantations and households:

WHEREAS, they also said that the recent flood had the worst case scenario ever and residents and barangay officials alike are worried that if the dam remains to be in place forever, one day barangay Tanglaw will be totally submerged and some parts might even be wiped out by raging floodwaters:

WHEREAS, a team composed of LGU officials and employees from the Municipal Engineer's Office, representatives of TADECO and TFCI, barangay officials of Tanglaw and others conducted a site inspection a week ago. Their recommendation as an answer to the problem was either to demolish the structure or to divert the course of the river, but both are unfortunately expensive and the activity will certainly take a long time;

WHEREAS, after a series of consultations including the recent one, the team had with Engr. Rogelio Bautista of NIA Carmen, to chip off the upper portion of the dam was seen to be the

most doable and lesser in terms of cost and time. Once chipped off, obstruction is avoided and water will already flow to downstream freely.

WHEREAS, the LGU and the barangay officials could not get the work started unless an authority coming from the NIA Regional Office is obtained, hence this resolution;

WHEREFORE, on motion of Hon. Joelito B. Juriana and duly seconded by Hon. Daniel G. Hilario; Hon. Julian J. Dujali, Jr; Hon. Romulo S. Esmino; Hon. Eduardo M. Zapata and Hon. Allan S. Paraguya, it is hereby
