**A RESOLUTION HUMBLY SOLICITING FROM THE HONORABLE CONGRESSMAN ANTONIO F. LAGDAMEO, JR. OF THE 2<sup>ND</sup> DISTRICT OF DAVAO DEL NORTE, FIVE (5) UNITS OF PORTABLE TOILETS ALSO KNOWN AS PORTALETS, TO BE USED DURING THE COOPERATIVE MONTH CELEBRATION TO BE HOSTED BY THE MUNICIPALITY OF BRAULIO E. DUJALI, THIS COMING OCTOBER 2011.**

**WHEREAS**, the Province of Davao del Norte will once again observe the cooperative month celebration in October and this time, it is the Municipality of Braulio E. Dujali's turn to host such a big event;

**WHEREAS**, the venue identified to be the only place capable to accommodate participating cooperatives from all over Davao del Norte, is the municipal gym, but sadly to say it does not have complete roofing, but despite the lack, something can be done like putting up of tarpaulins to prevent participants from being exposed to sunlight and rain;

**WHEREAS**, another concern of this body is that the gym does not have even a single rest room. Participants including our municipality's delegation during last year's celebration in one of the local government units of Davao del Norte had a very bad experience about the inability of the host municipality to provide restrooms wherein people can go to relieve themselves from the call of nature, as they had to climb uphill to reach the municipal hall situated very distant. This unfortunately had resulted to many clamors and negative feedbacks;

**WHEREAS**, the Municipality of Braulio E. Dujali does not want that experience to happen again in its own turf, as it intends to provide the comfort to its visitors during that celebration, nevertheless, considering the very limited financial resources it has as of the moment, hence it cannot do otherwise than ask assistance from the Honorable Congressman for the provision of these very important facility to be put within the venue's premises;

**WHEREFORE**, on motion of Hon. Joelito B. Juriana and duly seconded by all members present, it is hereby
