MUNICIPAL ORDINANCE NO. 2012-155

AN ORDINANCE PRESCRIBING THE RULES AND REGULATIONS FOR THE ENROLLMENT OF QUALIFIED RECIPIENTS TO PHILHEALTH PROGRAM OF THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHIC) AND FOR THE LOCAL GOVERNMENT OF BRAULIO E. DUJALI TO APPROPRIATE FUNDS FOR ITS IMPLEMENTATION.

BE IT ENACTED by the Sangguniang Bayan that:

SECTION 1. DECLARATION OF POLICY. There shall be a policy governing in the enrollment of qualified recipients to the PhilHealth program of the Philippine Health Insurance Corporation (PHIC) and for the LGU to allocate funds and to subsidize the premium of the beneficiaries.

SECTION 2. DEFINITION OF TERMS.

- a) Allocate – refers to appropriation
- b) Subsidize – refers to the financial support of the LGU
- c) Premium – refers to the amount paid to PHIC
- d) Qualified recipients – any interested applicants who may fall under any of the category specified herein.

SECTION 3. PROCEDURES IN THE IDENTIFICATION AND ENROLLMENT TO PHILHEALTH PROGRAM.

- 1) Applicants/Beneficiaries are categorized into:
 - a) Category A –an individual who can afford to pay the annual insurance premium to Philhealth.
 - b) Category B – Barangay Officials and functionaries; Barangay Nutrition Scholars, Barangay Health Workers, Barangay Sanitary Inspectors, Day Care Teachers, Purok Leaders, Barangay Police, Lupang Tagapamayapa, Barangay Agrarian Reform Chairman regardless of their annual income , will pay the 50% premium

and the other 50% premium shall be subsidized by the LGU, as privilege being partners / service providers.

- c) Category C – Poor individuals as assessed by the MSWDO will pay the 50% premium and the other 50% premium shall be subsidized by the LGU.
 - d) Category D – an individual who belongs to the poorest of the poor as assessed and identified by the MSWDO, whose annual premium shall be entirely shouldered by the LGU.
 - e) Category E.- disabled person , who after MSWDO assessment may pay or avail of the premium privileges specified in the foregoing categories.
- 2) Applicants / beneficiaries who will be prioritized for endorsement to PHIC membership are only those who pay the required premiums as assessed by the MSWDO, except for category D.

SECTION 4. REQUIREMENTS FOR ENROLLMENT

- a) Old Philhealth ID card
In the absence of Philhealth ID card
 - 1. Duly accomplished Philhealth Enrollment Form
 - 2. Community Tax Certification
 - 3. Dayong Certification
 - 4. Payment of premium
 - 5. Appointment
 - 6. For PWD-present ID card
 - 7. Others as required by the implementing agency.

- b) Deadline for payment of PHIC premium for the succeeding year (2013) shall be on October 1 to December 31, 2012 and on the same quarter every year thereafter

SECTION 5. MANNER OF PAYMENT. Premium shall be paid directly to the Office of the Municipal Treasurer and a corresponding official receipt shall be issued to paying client.

SECTION 6. BUDGETARY REQUIREMENT. The amount of P500,000 shall be allocated from the General Fund of each year.

SECTION 7. REPEALING CLAUSE. Any ordinance, order and other issuances that are not in consonance to this ordinance shall be repealed accordingly.

SECTION 7. EFFECTIVITY. This ordinance shall take effect upon approval.
