**Explanatory Note**

The LGU of Braulio E. Dujali is a fourth class municipality. Its income primarily came from the IRA shares, permits and taxes paid by taxpayers and investors, and same are used to finance programs and projects aimed at uplifting the total whole being of each and every constituent. However, never did this LGU managed to achieve 100% percent of its yearly collection target thereby affecting its operation especially so in project implementation. In effect, programs and projects deemed of least priority get unfunded and their respective appropriations are declared savings and consequently augmented to another item or items of the same expense classification. This usually takes time. So, to avoid this time consuming legislative process, hence the adoption of this ordinance.

MUNICIPAL ORDINANCE NO. **2012-156**

**AN ORDINANCE GIVING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE AND THE PRESIDING OFFICER TO AUGMENT FUNDING OF A CERTAIN ITEM OR ITEMS UNDER THEIR RESPECTIVE OFFICES/DEPARTMENTS INTEGRATED IN THE ANNUAL BUDGET TO ANOTHER ITEM OR ITEMS OF THE SAME EXPENSE CLASSIFICATION.**

**BE IT ENACTED** by the Sangguniang Bayan that:

**SECTION 1.** It shall be the policy of this municipality to authorize both the Local Chief Executive and the Presiding Officer to augment funding of certain item or items under their respective offices/departments integrated in the annual budget to another item or items of the same expense classification.

**SECTION 2.** This ordinance shall take effect immediately.
