MUNICIPAL ORDINANCE NO. **2013-163**

AN ORDINANCE DECLARING THE SECOND WEEK OF DECEMBER OF EACH YEAR AS “LINGGO NG KABATAAN” CELEBRATION IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE AND PROVIDING FUNDS THEREOF.

BE IT ENACTED by the Sangguniang Bayan that:

SECTION 1. The second week of December of each year shall be declared as “Linggo ng Kabataan” in the Municipality of Braulio E. Dujali in consonance with 439 of Republic Act 7160, otherwise known as the Local Government Code of 1991.

SECTION 2. To ensure a meaningful observance of the said occasion, during said week, this includes the election of the counterparts of all elective and appointive officials, as well as the heads of national offices or agencies stationed/assigned in the LGU and barangay, among in-school and community youth residing in the LGU concerned from ages 13 to 17.

SECTION 3. ALLOCATION OF BUDGET EVERY YEAR:

To defray the operational expenses necessary for the effective implementation of this ordinance, funds shall be integrated in the annual budget of the municipal government in the amount of One Hundred Thousand Pesos (P 100,000.00).

SECTION 4. SIGNIFICANCE/RELEVANCE:

- To make this celebration an official activity of the SK in the Municipality of Braulio E. Dujali.
- It would become part of the regular programs of the SK every year and funds for the activities will be allocated.
- It boosts the morale, confidence and leadership of the youth

- d) Youths take pride and honor in once in a lifetime experience as Young Municipal and Barangay Officials and National and Municipal Government department heads.

SECTION 5. DEFINITION OF TERMS:

YOUTH - refers to participants aging 13-17 years old

LINGGO NG KABATAAN – refers to activity of the Sangguniang Kabataan held every December

SECTION 6. OTHER ACTIVITIES DURING THE LINGGO NG KABATAAN CELEBRATION.

- a) Turnover and Oath Taking Ceremonies
- b) Commemoration of young Filipino heroes in our locality who made significant contributions to the development of the country or the locality.
- c) Recognition and awarding of outstanding youth organizations for their achievements & contributions to local or national development.
- d) Tree Planting
- e) Blood Letting
- f) Gift/Food Giving to the home for the Aged & Street Children
- g) Information Dissemination of "HIV Awareness".
- h) Community Service

SECTION 7. REPEALING CLAUSE. All ordinances, orders, rules and regulations or parts thereof, which are inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

- 1. **SECTION 8. EFFECTIVITY CLAUES.** This Ordinance shall take effect immediately upon its approval.
