MUNICIPAL ORDINANCE NO. **2013-164**

AN ORDINANCE PROVIDING SAND AND GRAVEL AS COMPLEMENTARY BURIAL ASSISTANCE FOR MEMBERS OF DAYONG ORGANIZATIONS AND INDIGENT FAMILIES IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE AND APPROPRIATING FUNDS THEREOF.

BE IT ORDAINED by the Sangguniang Bayan of Braulio E. Dujali, Davao del Norte in session that:

SECTION 1. Dayong organizations are non-formal organizations whose members gather to help lighten the burden of families at the time of death of their loved ones.

SECTION 2. Sand and gravel shall be allocated by the Municipal Government thru the Municipal Engineering Office to Dayong Organizations and indigent families as complementary assistance for the burial of a dead member.

SECTION 3. A stockpile of sand and gravel shall be maintained and be made available by the Municipal Engineering Office.

SECTION 4. Dayong Officials shall issue membership certification to the bereaved family which to be submitted to the Municipal Social Welfare and Development Office (MSWDO) and later to the Municipal Engineering Office for record and action. In case of indigent families who are non-Dayong members the MSWDO shall give them a written endorsement to the Municipal Engineering Office in order to avail of the said assistance.

SECTION 5. The concerned family shall be responsible for the hauling and transporting of the sand and gravel from the stockpile of the LGU to the cemetery.

SECTION 6. There must be an amount of Thirty Thousand Pesos (Php30,000.00) automatically appropriated annually for the purpose under the Municipal Engineering Office.

SECTION 7. This ordinance shall take effect upon approval by the Sangguniang Panlalawigan.
