**AN ORDINANCE ISSUING CITATION TICKETS FOR THE VIOLATION OF TRAFFIC RULES AND REGULATIONS IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.**

**BE IT ORDAINED** by the Sangguniang Bayan of Braulio E. Dujali, Davao del Norte in session that:

**ARTICLE I – TITLE**

**SECTION 1.**The title of this Ordinance shall be "Citation Ticket Ordinance."

**ARTICLE II – PURPOSE**

**SECTION 2.**The purposes of this ordinance are as follows:

To protect the life and property of any individuals from reckless drivers; and  
To be able to control and ease the flow of traffic.

**ARTICLE III – SCOPE AND COVERAGE**

**SECTION 1.**The coverage of this ordinance are those traffic related offenses that are committed within the Municipality of Braulio E. Dujali.

**ARTICLE IV – PUNISHABLE VIOLATIONS**

**SECTION 2.** List of Offenses:

Unregistered Motor Vehicle  
Driving without license  
Unfranchised Vehicle/No Municipal Permit/Sticker  
Invalid or suspended/Revoked/Expired Certificate of Registration and Official Receipt  
Overloading  
Outside line (out of line)  
Student driver not accompanied by a licensed driver  
Discourteous driver/conductor  
Certificate of Registration/Official Receipt not carried  
Certificate of Public Carrier/Permit not carried  
Unauthorized or improvised plate  
No required Motor Vehicle parts/accessories  
No early warning device  
No capability warning  
No body number, not for hire Motor Vehicle  
No tailgate/not for hire sign  
No front panel route  
Unauthorized wearing of slippers/shirt  
Allowing passengers on top of Motor Vehicles  
Reckless driving  
Obstruction  
Racing on road or street  
Failure to stop on entering a "thru stop street"  
Speeding or fast driving over 20 km/hr. within Poblacion area  
Entering a "Do not enter" sign  
Disregarding "No left turn and right turn" sign  
Allowing passenger in excess of sitting capacity  
Soliciting passengers at the street corner  
Loading and unloading of passengers and baggages at undesignated area  
Illegible and partly hidden plate number  
Without proper headlights, tail light and stop light  
Driving while under the influence of liquor or narcotic drugs  
Hostility or arrogance of a driver towards apprehending authority  
Arrogance, hostility and disrespect to passengers without valid reason.  
Selective solicitation/loading of passengers  
Non wearing of helmet with ICC Sticker including passengers  
Motor vehicle without side mirrors  
Wearing of Bonnet  
Trip-cutting  
Owner of motorcycle who allows minor to operate/drive shall be penalized  
Any other violation specified by the Land Transportation Office (LTO)

**ARTICLE V – PENALTY**

**SECTION 3.** Any person who commits offenses enumerated in the foregoing section shall be punished by a fine of One Hundred Fifty Pesos (Php150.00) per violation or an imprisonment of 5 days or both upon the discretion or any competent court. All payments shall be made at the Municipal Treasurer's Office and the latter shall issue a corresponding receipt.

**ARTICLE VI – PRODUCTION OF CITATION TICKETS**

**SECTION 4.** The Municipal Treasurer is hereby directed to produce the form of citation ticket that shall be used by the traffic officer, enforcer or any deputized personnel but subjected to the rules and regulations set by the proper authorities.

**ARTICLE VII – REPEALING CLAUSE**

**SECTION 5.** Any ordinance found inconsistent with this ordinance is hereby modified or repealed.

**ARTICLE VIII – SEPARABILITY CLAUSE**

**SECTION 6.** Any part of this ordinance that is declared null and void shall not have any effect on the entirety of the ordinance.

**ARTICLE IX – EFFECTIVITY CLAUSE**

**SECTION 7.** This ordinance shall take effect upon approval by the Sangguniang Panlalawigan.
