A RESOLUTION REQUESTING THE HONORABLE SECRETARY MANUEL A. ROXAS OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT TO ASSIGN ONE (1) UNIT FIRE TRUCK IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, it is high time now that this Local Government Unit will have a fire truck and a fire station of its own considering the number of fire incidents in this municipality, and the most recent was a fire that burned down the municipal public market;



WHEREAS, authorities said that fire is too fearful because of its ability to turn everything to ashes in an instant, and that firefighters have to be on the fire scene in five (5) minutes and it is impossible in the case of the Municipality of Braulio E. Dujali wherein responding teams have yet to come from the Municipality of Carmen which is 12 or more kilometers away or from the Cities of Tagum and Panabo, both are 15 and 25 or more kilometers away, respectively;

WHEREAS, development and progress are now taking place in this municipality wherein economic activities have become vibrant as evidenced by various structures especially in the commercial area, a place considered highly vulnerable to conflagration;


WHEREAS, this Local Government Unit remains to be financially incapable to buy its own fire truck. In effect, this body resorted to seeking assistance from the national agencies, but sadly to say requests seem to have fallen on deaf ears. This LGU's meager resources also could not warrant purchase of even a single unit, thus the need, once again to seek help from the DILG thru the Honorable Secretary, with a commitment that this LGU will identify or even has already identified an area for its future fire station;

WHEREFORE, on motion of Hon. Romulo R. Esmino, Sr. and duly seconded by majority of all the members present, it is hereby
