A RESOLUTION AMENDING FURTHER RESOLUTION NO. 2013-01 PARTICULARLY IN SECTION 34 RULE IX, BY CREATING THE 15TH COMMITTEE TO BE KNOWN AS THE COMMITTEE ON CULTURAL COMMUNITIES AND BRAULIO E. DUJALI HISTORICAL AND CULTURAL AFFAIRS AND ADOPTING THE PLACEMENT OF HON. FRANCISCO D. BUCADON AS THE CHAIRMAN.

WHEREAS, RA 8371 or known as the IPRA Law stipulates mandatory representation of indigenous people in local sanggunians at all levels,

WHEREAS, in pursuance to such mandate, hence the election of Hon. Francsico D. Bucadon and his subsequent official assumption as legitimate member of the local legislative council;

WHEREAS, equally necessary also is the amendment of this Sangguniang Bayan's Internal Rules of Procedures by creating the 15th committee to be added to the 14 existing committees of which Hon. Bucadon will automatically become its Chair, and functions of the said committee shall include but not limited to take focus on

matters affecting the general welfare of indigenous people living in the locality;

WHEREFORE, on motion of Hon. Gregorio S. Facula and all members voted in favor, hence
