**AN ORDINANCE INSTITUTIONALIZING THE MUNICIPALITY OF BRAULIO E. DUJALI PROGRAM "TAPAT MO LINIS MO" (CLEAN YOUR IMMEDIATE SURROUNDINGS), PRESCRIBING GUIDELINES TO ITS IMPLEMENTATION AND PROVIDING PENALTIES TO VIOLATORS THEREOF.**


**EXPLANATORY NOTE**

The "TAPAT MO LINIS MO" program of the Municipality of Braulio E. Dujali, Davao del Norte has resulted in a good awareness among the Municipality's residents of the virtues of a community wide clean up campaign;

The institutionalizing of the "TAPAT MO LINIS MO" slogan is also in support and in adherence to the provisions of Section 3 of R.A. 7160 which provides that the Local Government Units (LGUs) shall share with the National Government the responsibility in the management and maintenance of Ecological balance within their territorial jurisdiction;

Section 447 (vi) of R.A. 7160 also empowers the Sangguniang Bayan to protect the environment and impose penalties for acts which endanger the Environment including such Activities which result in Pollution of Creeks and Rivers or of Ecological imbalance;

The Municipal Mayor and the Sangguniang Bayan believe that the unwarranted and disorderly garbage disposal should not only be the problem of the LGU but the community's responsibility as well;

A Clean and Healthy Environment breeds Healthy, Wealthy and Intelligent Community members.

SECTION 1. TITLE- AN ORDINANCE INSTITUTIONALIZING THE MUNICIPALITY OF BRAULIO E. DUJALI PROGRAM "TAPAT MO LINIS MO" (CLEAN YOUR IMMEDIATE SURROUNDINGS), PRESCRIBING GUIDELINES TO ITS IMPLEMENTATION AND PROVIDING PENALTIES TO VIOLATORS THEREOF.

SECTION 2. PROVISION OF THE ORDINANCE

- a. All Business establishments within the juridical boundaries of the Municipality of Braulio E. Dujali, must see to it that their premises, including the frontage of their properties where they do business must be free from litters.
- b. All residential owners/tenants must see to it that their premises must be free from garbage and litters including their immediate property frontage, both sides and back portion.
- c. All owners/tenants of residential and business establishments located/situated in Canals, drainage systems, creek and river banks and other waterways must also see to it that their portion of the area must be free from garbage or litters that may cause blockade of the water passages.

SECTION 3. IMPLEMENTING RULES AND GUIDELINES - Within thirty (30) days from the approval of this Ordinance, the necessary rules and regulations shall be issued by the Mayor for the proper and effective implementation of this Ordinance.

SECTION 4. PENALTIES - All residential owners/tenants and business establishments who violates any of the prohibited acts stated above shall be punished through the imposition of the following penalties:

First Offense - P500.00 fine

Second Offense -P1, 000.00 fines

Third Offense - P2,500.00 and /or imprisonment upon discretion of the Court and in the case of business establishments, cancellation of their License to operate for a period of one(1) year.



SECTION 6. REPEALING CLAUSE - All previous Ordinances inconsistent with this Ordinance shall be deemed repealed or modified accordingly.


SECTION 7. EFFECTIVITY - This Ordinance shall take effect upon its approval by the Sangguniang Bayan.


