WHEREAS, presented for consideration and deliberation of this honorable body was the CY 2015 General Fund Annual Budget of Barangay Dujali, this municipality;

WHEREAS, this body has made a careful study on the said subject matter, and focused its attention on as well adopted, the recommendations given by the Local Finance Committee that the budget, despite to have substantially



complied the provisions of the Local Government Code, the following should have been also observed:

- 1) Actual payment of Leave Benefits of Barangay Officials should have conformed with the provisions of the CSC and DBM Joint Circular No. 1 s 2014;
- 2) That they should have adhered to DILG and DBM Joint Memorandum Circular No. 2011-1 pertaining to the implementation of the 20% Development Fund;
- 3) They should have strictly observed the provisions of RA 10121, in the utilization of funds appropriated for BDRRMF;
- 4) To comply with this recommendations in their future budget enactments.
