A RESOLUTION DECLARING OPERATIVE, CY 2015 GENERAL FUND ANNUAL BUDGET OF BARANGAY TANGLAW, BRAULIO E. DUJALI, DAVAO DEL NORTE, TO TAKE EFFECT ON THE DATE STATED FOR ITS EFFECTIVITY.

WHEREAS, the General Fund Annual Budget of Barangay Tanglaw, this municipality was presented before this body for deliberation and appropriate action;

WHEREAS, this honorable body made a careful study on the matter and thereafter a finding came up that despite the said budget has substantially complied with provisions of the Local Government Code, however, it should have strictly conformed to the provisions of CSC and DBM Joint Circular No. 1 s 2004, as to the actual payment of Leave Benefits of Barangay Officials, that is



amounting to P191,835.51; and that it should have adhered to DILG and DBM Joint Memorandum Circular No. 2011-1, as far as implementation of appropriations for the 20% Development Fund; and lastly, it should have utilized in conformity to provisions of RA 10121, the 5 % BDRRMF; the excess in the appropriations for Discretionary Fund must be reverted to the unappropriated balance and that procurement of goods and services shall strictly be in conformity with RA 9184;

WHEREAS, this body enjoins the concerned barangay the strict adherence of existing mandates as well as of the foregoing observations in their succeeding similar legislations;

WHEREFORE, on motion of Hon. Leah Marie A. Moral-Romano and duly seconded by majority of the members present, it is hereby
