RESOLUTION NO. 2013-31

A RESOLUTION GIVING AUTHORITY TO MAYOR LOLITA A. MORAL ON BEHALF OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, TO ENTER INTO A CONTRACT OF AGREEMENT WITH THE ALLIED TRADE RESOURCES MULTI-PURPOSE COOPERATIVE, IN CONNECTION WITH THE IMPLEMENTATION OF THE SALINTUBIG PROGRAM OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT.

WHEREAS, water for drinking and for other domestic uses was once source in this municipality. It being a primary necessity, this local government unit had endeavored to establish a local water system that secured the town proper and its barangays, but not Magupising yet;

WHEREAS, most of the residents of Magupising in the meantime use rainwater or open well. The water they get from these sources is not safe as the place is too close to banana plantation and flood is frequent that their well are always submerged with muddy flood waters from upstream, thus their fear of contamination;

WHEREAS, the SALINTUBIG project of the DILG to be put in place in Magupising is a welcome development not just for the LGU but most importantly for the people who will benefit the project;

WHEREAS, considering the foregoing premise, this honorable body upon motion of Hon. Restie E. Tabirao and duly seconded by Hon. Joelito B. Juriana, Hon. Daniel G. Hilario, Hon. Allan S. Paraguya and Hon. Eduardo M. Zapata, moved hereby;

RESOLVED TO GIVE AUTHORITY AS THIS BODY HEREBY GIVES AUTHORITY TO MAYOR LOLITA A. MORAL ON BEHALF OF THE MUNICIPALITY OF BRAULIO E.
