


WHEREAS, the catering services- meals and snacks was published for seven (7) days for second (2nd) bidding but no one intended to bid;


WHEREAS, no prospective bidder intended to bid for the catering services- meals and snacks within period of the advertisement;



RESOLUTION NO. 095. 2012




