WHEREAS, during the conduct of this Sangguniang Bayan's 40th regular session on October 22, 2015, Hon. Gregorio S. Facula, Sangguniang Bayan Member, delivered his privilege speech on the matter pertaining to the stalled concreting of road connecting Barangay Cabayangan to Barangay Magupising, this municipality;

system and policy relating to implementation of national government funded projects;
