WHEREAS, due to the resignation of Atty. Yasmin V. Campion, Municipal Administrator for Internal Affairs effective October 14, 2015 and the retirement of Mr. Nelson C. Baer, Municipal Administrator for External Affairs effective October 16, 2015, from the government service, designation of a new Local Administrator is hereby necessary;

WHEREAS, Memorandum Order No. 46 s-2015 dated October 13, 2015 issued by the Local Chief Executive states the designation of Mr. Norbelito B. Juriana as Municipal Administrator for Internal Affairs to countersign in all checks drawn by the Municipal Treasurer;

WHEREAS, Section 345 of the RA 7160 also known as the Local Government Code of 1991 states that checks in settlement of obligations shall be drawn by the Local Treasurer and countersigned by the Local Administrator;

WHEREAS, in order to conform to such mandate, Mr. Norbelito B. Juriana, the designated Municipal Administrator for Internal Affairs is authorized to carryout the duties and responsibilities stipulated in the foregoing, with the end view of achieving in this LGU a strengthened and a more expeditious internal control system;

WHEREFORE, on motion of Hon. Leah Marie A. Moral-Romano and duly seconded by all members present, it is hereby
