DUJALI, DAVAO DEL NORTE.

WHEREAS, various projects of the Municipality of Braulio E. Dujali shall be financed by the Land Bank of the Philippines, Davao City and the component of loan is the construction of the Municipal Public Cemetery/Memorial Park;

WHEREAS, the Republic Act 8473, an Act Creating the Municipality of Braulio E. Dujali in the Province of Davao del Norte and for Other Purposes. 
