ABAD, SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT TO APPROPRIATE FUNDS IN THE AMOUNT OF FIFTEEN MILLION PESOS (PHP 15,000,000.00) TO BE USED IN THE CONSTRUCTION OF FARM TO MARKET ROAD AT DISTRICT 2, (DCC) BARANGAY TANGLAW, BRAULIO E. DUJALI, DAVAO DEL NORTE AND FOR OTHER PURPOSES THEREOF.**

WHEREAS, it is hereby declared the policy of the state that the territorial and political subdivisions of the state shall enjoy genuine and meaningful local autonomy to enable them to attain their fullest development as self-reliant communities and make them more effective partners in attainment of national goals;

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991, allows the National Government Agencies to implement nationally funded projects, facilities program and services jointly with the assistance of Local Government Units;

WHEREAS, establishing linkages and networks to various national government agencies especially the Department of Budget and Management for financial support for the implementation of program/project herein specified it being listed in the Local Development Investment Plan which form part the Comprehensive Development Plan and the Executive Legislative Agenda, is considered very necessary, hence this resolution;

WHEREFORE, on motion of Hon. Romulo R. Esmino, Sr. with all members present voted in favor, hereby


