FOREWORDS

Barangay Officials play a very important role in local governance, particularly in the promotion of the general welfare of their constituents, yet they receive only small amount of their honoraria. Each time a Barangay Official gets sick which requires hospitalization his/her family is often hard-pressed to look for the money for the purchase of medicines and payment of hospital bills. Because of financial hardship Barangay Officials who are severely injured or afflicted with serious ailment are unable to buy the medicines and other medical needs essential for their recovery.

It is sad to note that in spite of their invaluable contribution towards the promotion of the general welfare of their constituents, Barangay Officials seem to be neglected by the government in so far as Hospitalization Assistance and other Medical benefits are concerned

Therefore, it is high time that our Government must show deep concern to the Health problem of the Barangay Officials by extending financial assistance to anyone of them who may be confined in the Hospital for serious injury or ailment, hence the adoption of this

MUNICIPAL ORDINANCE NO. 2011-146

"AN ORDINANCE GRANTING HOSPITALIZATION ASSISTANCE TO BARANGAY OFFICIALS WHO ARE CONFINED IN THE HOSPITAL FOR SERIOUS INJURY OR AILMENT AND PROVIDING FUNDS THEREFOR"

Authored by Hon. JOELITO B. JURIANA Co- Author: Hon. EDUARDO M. ZAPATA BE IT ORDAINED, by the Sangguniang Bayan of Braulio E. Dujali in session assembled, that:

- SECTION 1. TITLE. This ordinance shall be known as the Barangay Officials Hospitalization Assistance Ordinance.
- SECTION 2. DECLARATION OF POLICY. It is hereby declared a policy of the Municipality of Braulio E. Dujali to extend Hospitalization assistance to Barangay Officials who may be confined in the Hospital for serious injury or ailment in recognition of the selfless, sincere and dedicated service to their Barangay constituents.
- SECTION 3. COVERAGE. The Barangay Captain, the regular members of the Sangguniang Barangay, the SK President, Barangay Secretary and the Barangay Treasurer are the Barangay Officials covered by this ordinance.
- SECTION 4. HOSPITALIZATION ASSITANCE. ANY Barangay Official subject of this Ordinance who is confined in the Hospital t is entitled to receive hospitalization assistance in the amount on Three Thousand Pesos (P3,000) for surgical cases and (P 2,000.00) for non-surgical cases, from the Municipal Government of Braulio E. Dujali after he has complied with the requirements embodied in this ordinance.
- SECTION 5. PROCEDURE IN THE AVAILMENT OF THE HOSPITALIZATION ASSITANCE.
 - 5.1 The Patient beneficiary or his/her authorized representative must secure a Barangay Clearance attesting that he/she is a bonafide resident of the said Barangay of the Municipality of Braulio E. Dujali;
 - 5.2 The Patient beneficiary or his/her authorized representative must secure a medical certificate from the hospital where he/she was confined;
 - 5.3 The Patient beneficiary or his/her authorized representative must secure a Barangay Certification, the Certificate of Confinement and his Oath of Office to the Office of the Municipal Mayor for the preparation of the vouchers covering the financial assistance;
 - 5.4 Only the spouse of the patient beneficiary, any of his/her children, brother or sister or Parents as the case may be is authorized to claim the Hospital benefits of the patient Beneficiary;
 - 5.5 If the spouse authorized is the authorized representative, he/she must present the Marriage Contract; if a child he/she must present his birth certificate; if parents, brother or sister .He/she must present one (1) valid I.D. or birth certificate;
 - 5.6 In the event the patient beneficiary has no close relatives in the Barangay, the Barangay Captain shall be designated as authorized representative.
- SECTION 6. FREQUENCY IN THE AVAILMENT FO HOSPITALIZATION ASSITANCE. Barangay Officials Covered by this Ordinance may avail of this Hospitalization assistance only once a year Regardless of the number of confinement/s in the Hospital.
- SECTION 7. FUNDING REQUIREMENTS. To carry out the purpose of this Ordinance the amount of one Hundred thousand Pesos (P100,000.00) shall be appropriated annually to be included in the annual budget of the Municipality.
