### **MUNICIPAL ORDINANCE NO. 2011-134**

"AN ORDINANCE GRANTING TEN THOUSAND PESOS (P10,000.00) FOR EVERY BARANGAY AS FINANCIAL AID IN THE CELEBRATION OF THEIR FOUNDING ANNIVERSARY".

BE IT ORDAINED by the Sangguniang Bayan in session assembled that;

SECTION 1. TITLE: There shall be an "ordinance granting the Ten Thousand Pesos (P10,000.00) for every barangay as financial aid in their celebration of founding anniversary".

# SECTION 2. DEFINITION OF TERMS.

- 2.1 Araw ng Barangay the annual founding celebration of the barangay.
- 2.2 Reportorial Requirement detailed document for purposes of audit.

# SECTION 3. GENERAL PROVISION.

- 3.1 Every barangay shall be provided of Ten Thousand Pesos (P10,000.00) as budgetary aid and it shall form part of their Trust Fund.
  - 3.2 Manner of utilization of fund shall be during the celebration of founding anniversary.
- 3.3 Release of funds shall be in accordance with the accounting and auditing rules and procedures.

SECTION 4. APPROPRIATION.

The Local Government Unit of Braulio E. Dujali shall appropriate in the Annual Budget a minimum of Ten Thousand Pesos (P10,000.00) for each barangay, which shall come from the Local Government Unit's General Fund.

## SECTION 5. SEPARABILITY CLAUSE.

If any part of this ordinance is declared illegal or constitutional, the rest of the provisions not affected thereby shall remain in full force and effect.

# SECTION 6. REPEALING CLAUSE.

Any ordinance or regulation inconsistent thereof is hereby deemed modified or amended accordingly.

SECTION 7. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.
