MUNICIPAL ORDINANCE NO. 2011-138

AN ORDINANCE REQUIRING A PERSON TO SECURE COMPLEMENTARY PHILHEALTH INSURANCE BEFORE UNDERGOING PRE-MARRIAGE COUNSELING SEMINAR IN THE MUNICIPALITY OF BRAULIO E. DUJALI.

BE IT ENACTED, by the Sangguniang Bayan that:

Section 1. Any person is hereby required to secure complementary Philhealth Insurance before undergoing Pre-Marriage Counseling seminar in the Municipality of Braulio E. Dujali.

Section 2. The purpose of this ordinance is to help provide new families an easy access to health care benefits of the government.

Section 3. The enrolment fee and premiums on Philhealth Insurance shall be paid by the applicant through the MSWDO for its application.

Section 4. The applicant shall present his/her Philhealth Insurance membership to the office of Braulio E. Dujali Municipal Social Welfare and Development as a requirement for Pre-Marriage Counseling seminar.

Section 5. Those who have Philhealth card must show the identification card to the MSWDO.

Section 6. For the effective enforcement of this ordinance, the Municipal Social Welfare and Development Office shall do the explanation on its purpose to a person who shall undergo Pre-Marriage Counseling seminar for his/her full understanding.

Section 7. This ordinance shall take effect after approval of the Sangguniang Panlalawigan.
