"AN ORDINANCE IMPOSING FEES TO PANEL PICK-UPS, PANEL TRUCKS, MULTICABS AND OTHER VEHICLES OF COMPANIES ENGAGED IN SELLING AND DISTRIBUTING DRY GOODS AND OTHER COMMODITIES IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE"

Be it ordained by the Sangguniang Bayan in session assembled that:

SECTION I. <u>DECLARATION OF POLICY.</u> It shall be the policy of Sangguniang Bayan to collect fees from panel pick-ups, panel trucks, multicabs and other vehicles of companies engaged in selling and distributing dry goods and other commodities in the Municipality of Braulio E. Dujali, Davao del Norte.

SECTION II. <u>MODE OF COLLECTION</u>. All collections being made on charges per entry for engaging business in the municipality of Braulio E. Dujali by the abovementioned shall be issued with a corresponding Official Receipt as follows:

Panel trucks P 50.00
Panel pick-ups P 40.00
Multicabs P 30.00
Other vehicles (lighter than muticabs) P 20.00

SECTION III. ISSUANCE OF OFFICIAL RECEIPT. The issuance of Official Receipt shall be made by the Office of the Municipal Treasurer through its duly authorized representative as collector.
