AN ORDINANCE PROVIDING FOR THE HOLDING OF "KAHAYAG UG KASADYA SA PASKO" IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.

SECTION 1. This Ordinance shall be known as "**KAHAYAG UG KASADYA SA PASKO**" in the Municipality of Braulio E. Dujali, Davao del Norte.

SECTION 2. This Ordinance shall cover the entire Municipality of Braulio E. Dujali.

SECTION 3. It is hereby declared a policy of the Municipality of Braulio E. Dujali to promote Joy, Peace, Unity and Goodwill during the Christmas Season.

SECTION 4. The Municipality of Braulio E. Dujali shall provide for the holding of the "**KAHAYAG UG KASADYA SA PASKO**" in the Municipality from December 1 to January 3 of every year.

SECTION 5. Under this Ordinance every Barangay shall participate in this "**KAHAYAG UG KASADYA SA PASKO**" by putting up a Belen and Christmas Decors that truly depict the spirit of Christmas. Big business

establishments may also be encouraged to join in the celebration; however, they will not be included in the competition.

SECTION 6. This Program is open to all interested Agencies, Establishments and Organizations existing within the Municipality of Braulio E. Dujali.

SECTION 7. All participants shall put up their entries within the government center of Braulio E. Dujali as the Venue of this activity.

SECTION 8. There shall be created an Oversight Committee which will be given full authority to facilitate the implementation of the Program to be composed of the following:

SECTION 9. Prizes in the form of cash shall be awarded to the winning entries.

SECTION 12. To carry out the purpose of this ordinance the amount of P100,000.00 Pesos shall serve as an initial allocation and to be included in the Annual/Supplemental Budget of the Municipality.

SECTION 13. Awarding of the Prizes shall be done during the Second week Convocation in the month of January.

SECTION 14. Any Ordinance, Resolution Order inconsistent with this Ordinance is hereby Repealed, Modified or Amended accordingly.

SECTION 15. This Ordinance shall take effect immediately upon approval .
