RESOLUTION NO. **2012 -07**

A RESOLUTION REQUESTING THE HON. JESSIE M. ROBREDO, SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) TO GIVE THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, AN UPDATE AS TO THE LATTER'S PREVIOUS REQUEST FOR A FUNDING ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (P 5,000,000.00) FOR THE CONSTRUCTION OF A FIRE STATION AND ACQUISITION OF ONE (1) UNIT FIRE TRUCK FOR THIS MUNICIPALITY.

WHEREAS, development has become apparent in this locality, large structures and various business establishments continue to mushroom within the locality's main thoroughfares, thus increasing the risk of conflagration;

WHEREAS, like a thief, nobody knows when a fire strike, hence preparation for quick response is necessary at all times, and this is what that is totally lacking in this municipality as the most basic facilities like fire station and a fire truck are not available in the locality;

WHEREAS, due the foregoing this body had adopted a resolution many months ago asking the Honorable Secretary of the DILG for possible allocation of a financial assistance for this purpose, but then, sad to say that until now this body did not receive any update yet as to the status of said request;

WHEREFORE, on motion of Hon. Daniel G. Hilario, and duly seconded by all members present, it is hereby

RESOLVED TO REQUEST AS THIS BODY HEREBY REQUESTS HON. JESSIE M. ROBREDO, SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) TO GIVE THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, AN UPDATE AS TO THE LATTER'S PREVIOUS REQUEST FOR A FUNDING ASSISTANCE IN THE AMOUNT OF FIVE MILLION

PESOS (P 5,000,000.00) FOR THE CONSTRUCTION OF A FIRE STATION AND ACQUISITION OF ONE (1) UNIT FIRE TRUCK FOR THIS MUNICIPALITY.
