WYCOCO, MPA, PROVINCIAL DIRECTOR, DNPPD, FOR THE POSSIBLE RETENTION OF P/I ZOSIMO FERNANDO JOSE, OIC OF BRAULIO E. DUJALI POLICE STATION, BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, information has reached this honorable chamber regarding the proposed replacement P/I Zosimo F. Jose as OIC of Braulio E. Dujali Police Station;

WHEREAS, this idea is no longer a surprise since this body is fully aware that no police officers with rank lower than a Police Senior Inspector can become a full-fledged Chief of Police of a particular station, however, in the case of P/I Zosimo F. Jose, he may have lacked in certain qualifications, but for the entire officialdom and the majority of the people with whom he had developed good rapport and who are living witness of his competence, his bravery, his dedication, his hard work, his character, his selflessness and all other qualities they deem important for a police head to possess, P/I Jose already had performed at par or may have surpassed the ability of those who previously occupied the post;

WHEREAS, P/I Jose's one of the most astounding accomplishments was when he led his men in the successful arrest of and bringing to justice the number one of the top ten (10) most wanted persons in the entire Province of Davao del Norte, after many failed attempts by past leadership and various law enforcement groups;
