RESOLUTION NO. **2012 -31**

**A RESOLUTION EXPRESSING WILLINGNESS OF THE MUNICIPALITY OF BRAULIO E. DUJALI TO PARTICIPATE IN THE IMPLEMENTATION OF THE NATIONAL HEALTH INSURANCE PROGRAM (NHIP) THRU THE PARTIAL SUBSIDY SCHEME, AUTHORIZING HONORABLE MAYOR LOLITA A. MORAL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PhilHealth).**

**WHEREAS**, Section II, Article XII of the 1978 Philippine Constitution declares that the state shall adopt an integrated and comprehensive approach to health development which shall endeavour to make essential goods, health and other services available to all people at affordable cost; priority for the needs of the underprivileged sick, elderly, disable, women and children shall be recognized. Likewise, it shall be the policy of the State to provide free medical care to paupers;

**WHEREAS**, to implement the aforementioned constitutional provisions, the Philippine Congress enacted Republic Act No. 7875 as amended by Republic Act No. 9241, "An Act Instituting a National Health Insurance Program (NHIP) and Establishing the Philippine Health Insurance Program (PhilHealth)" for the purpose;

**WHEREAS**, the National Health Insurance Program (NHIP) provides a mechanism to grant membership to low income families under the NHIP through sponsorship by the Local Government Units (LGUs). It will enable them access to medical services in all NHIP accredited providers;

**WHEREAS**, section 29 (t), Rule IV of the Implementing Rules and Regulations of the Republic Act (R.A.) No. 7875, as amended, provides that "the partial subsidy scheme may be adopted for indigents who are proposed to be enrolled by the LGU or premium donor/s but do not qualify for full subsidy under the means test rule xxx";

**WHEREAS**, the Body, considering the beneficent features of RA 7875 as it will vastly improve the over-all health status of the population and ultimately, their general quality of life and rationalize the Municipal Government's expenditure for health, collectively agreed to adopt the National Health Insurance Program (NHIP) of the National Government.

**WHEREAS**, the Municipal Government of Braulio E. Dujali through Honorable Mayor Lolita A. Moral and the Honorable Members of the Sangguniang Bayan committing and agreeing to shoulder the amount needed to cover LGU identified poor families in the municipality;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, to adopt the National Health Insurance Program of the National Government and its Implementing Rules and Regulation for In-Patient and Outpatient services to cover LGU identified indigent families of Braulio E. Dujali;

**RESOLVED THAT**, the Sangguniang Bayan of the Municipality of Braulio E. Dujali will authorize the Honorable Mayor Lolita A. Moral to enter and sign an agreement with the Philippine Health Insurance Corporation, represented by its President and CEO, Dr. Eduardo P. Banzon adopting the NHIP of the National Government and provide health care services to the LGU identified indigent families in Braulio E. Dujali;

**RESOLVED FURTHER THAT**, the Sangguniang Bayan of the Municipality of Braulio E. Dujali shall cause the enactment of an ordinance allocating funds from its appropriations for health services to finance the premium contributions of its identified indigent families.

**RESOLVED, FINALLY**, to furnish copy of this Resolution to the President of the Philippines, **HIS EXCELLENCY, PRESIDENT BENIGNO AQUINO, III**, the President and Chief Executive Officer of the Philippine Health Insurance Corporation, **Dr. EDUARDO P. BANZON** for their information.
