RESOLUTION NO. **2012-56**

A RESOLUTION RETURNING BARANGAY ORDINANCE NO. 026 S. 2012, OTHERWISE KNOWN AS AN ORDINANCE REGULATING THE SPEED LIMIT OF MOTOR VEHICLE ENTERING AREA OF BARANGAY NEW CASAY, BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, this Barangay Ordinance No. 026 s. 2012, was presented before this body for deliberation;

WHEREAS, a thorough discussion among members, and they later found out that the penalty to be imposed on violators is too high or exorbitant, making it inconsistent with existing laws;

WHEREAS, this body recommends that the barangay of origin have to lower the penalty into an amount not exceeding One Thousand Pesos (P 1,000.00) in pursuance to section 391 para 14 of RA 7160;
