RESOLUTION NO. **2012-68**

**A RESOLUTION DISAPPROVING THE REQUEST OF THE HONORABLE MAYOR LOLITA A. MORAL, TO ENACT AN ORDINANCE AUTHORIZING THE BORROWING IN THE AMOUNT OF FIFTEEN MILLION PESOS (P 15,000,000.00) FROM THE LAND BANK OF THE PHILIPPINES, PANABO CITY BRANCH.**

**WHEREAS**, Mayor Lolita A. Moral has sent a letter to the Sangguniang Bayan, requesting among others that an ordinance be adopted authorizing the borrowing in the amount of Fifteen Million Pesos (P 15,000,000.00) from the Land Bank of the Philippines, Panabo City Branch;

**WHEREAS**, the amount mentioned is said to be used to acquire the following facilities deemed vital to the operations of the LGU with their corresponding funding requirement:

<b>1) Purchase of Meat Van</b>	P	300,000.00
<b>2) Purchase of Medical Service Vehicle</b>		700,000.00
<b>3) Purchase of Land for Housing Project</b>		4,000,000.00
<b>4) Market Development with terminal component</b>	P	<u>10,000,000.00</u>
<b>Total</b>	<b>P</b>	<b>15,000,000.00</b>

**WHEREAS**, such request was referred for study to the Committee on Finance and Appropriation, after which came up with the following findings and recommendations, to wit:

- 1) Except for the market development with terminal component, all other projects listed in the foregoing are not found in the Approved Local Development Investment Plan (LDIP) for CY 2011-2013 and Annual Investment Plan (AIP) for CY 2012;**
- 2) No approved Feasibility Study to ascertain projects viability, and likewise the LBP's requirement;**
- 3) The Municipal Development Council and not the Budget Call is the right forum in identifying priority programs and projects;**

- 4)** *The action if the Sangguniang Bayan on the first request of Mayor Lolita A. Moral to avail of a P 25,000,000.00 loan was for the Executive Department to come up with Feasibility Study, Amended LDIP, Amended AIP and other recommendations as per SB Committee Report, but sadly to say, the Executive Department failed to adhere to said recommendations, but instead pass another similar request with only the amount reduced to P 15,000,000.00 from the original P 25,000,000.00;*

**WHEREAS**, this body thereafter decides not to grant the Mayor's request on the basis of the foregoing premise;

**WHEREFORE**, on motion of Hon. Ramon D. Magtulis III and duly seconded by all members present, it is hereby

**RESOLVED TO DISAPPROVED AS THIS BODY HEREBY DISAPPROVES THE REQUEST OF THE HONORABLE MAYOR LOLITA A. MORAL, TO ENACT AN ORDINANCE AUTHORIZING THE BORROWING IN THE AMOUNT OF FIFTEEN MILLION PESOS (P 15,000,000.00) FROM THE LAND BANK OF THE PHILIPPINES, PANABO CITY BRANCH.**
