A RESOLUTION REQUESTING CHAIRMAN MARGARITA P. JUICO, OF THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE, MANILA FINANCIAL ASSISTANCE IN THE AMOUNT OF TEN MILLION PESOS (P10,000,000.00) TO BE USED BY THE MUNICIPAL HEALTH OFFICE IN THE PROCUREMENT OF VITAL MEDICAL EQUIPMENT AS WELL AS MEDICINES NEEDED IN PREVENTING AND CURING COMMON AILMENTS EXPERIENCED IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, the Municipality is a fast growing municipality. It being a lot to offer in terms of employment and business opportunities, people from other localities came and their member including the existing residents has heightened the LGU's responsibility of providing their basic needs, most importantly the regular and adequate supply of medicines to be used in the prevention and cure of even their most common ailments;

WHEREAS, the sad part of having inadequate supply of medicines is that people are forced to buy generic medicines from pharmacies. The lesser the price, the slimmer are the chances of getting well, and the worst is that some opted to self medicate, thereby putting their own life to risk;

WHEREAS, the municipality also has established a new birthing facility, but then it cannot get started to fully operate since no single equipment available especially for newborn screening, as well as medicines too;
