A RESOLUTION DISAPPROVING MDC RESOLUTION NO. 7 S-2012, OTHERWISE KNOWN AS A RESOLUTION REQUESTING FOR RECONSIDERATION THE INCLUSION IN THE LIST OF PROGRAMS AND PROJECTS UNDER THE CARE OF FIFTEEN MILLION PESOS (P 15,000,000.00) LOAN FROM THE LAND BANK OF THE PHILIPPINES, THE PURCHASE OF LOT IN THE AMOUNT OF FOUR MILLION PESOS (P 4,000,000.00).

WHEREAS, MDC Resolution No. 7 s- 2012, was presented before this body for deliberation;

WHEREAS, an emphatic, lengthy and yet healthy discussion ensued, each and every member taking sides and giving his opinion as to the worthiness of the Four Million (P4,000,000.00) peso lot purchase project to be included as among the priorities to be embodied be it in the Annual Investment Plan or Supplemental Annual Investment Plans;

WHEREAS, the discussion of the council only proved that majority of the members are still not convinced as to the usability of the project, much less of its economic returns despite being provided with textual assessment which enumerates all its present and future usefulness;

WHEREAS, the council remain to stand firm on its decision it has made earlier not to favor the inclusion of lot purchase amounting to Four Million Pesos (P 4,000,000.00) as among those to be funded out of the Fifteen Million Pesos (P 15,000,000.00) loan from the land bank of the Philippines;
