**WHEREAS**, complaints reaching this Sangguniang Bayan that a cableway is traversing a road in Sitio Bacali, this facility gave not only inconvenience but also hazard to passers-by specially the motorists;

**WHEREAS**, some of the members of this council attested to the truthfulness of the information but as per assessment, the LGU cannot in anyway act in the manner people wanted it to, such as to order stoppage of operation or direct people who use this cableway to institute measures that would ascertain safety for reasons that the site in which it is located is a provincial road;
