A RESOLUTION REQUESTING HON. MAR ROXAS SECRETARY OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, THRU THE HON. ANTONIO F. LAGDAMEO JR. CONGRESSMAN OF DISTRICT II, DAVAO DEL NORTE, TO GIVE ONE (1) UNIT FIRETRUCK TO THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE.

WHEREAS, the Municipality of Braulio E. Dujali is more or less 15 kilometers away from Tagum City, 12 kilometers from Municipality of Carmen and 17 kilometers from the City of Panabo. These Local Government Units are the nearest that have available units of firetruck, that in case of fire incident in this locality, they are the ones we can call up to;

WHEREAS, according to experts, a fire can raze off a structure made up of light materials and turn everything into ashes only in ten (10) minutes, and this could possibly happen in Braulio E. Dujali wherein responding firetrucks will come from the LGU's mentioned earlier;

WHEREAS, a firetruck is now considered a very important facility that this LGU must really have considering the fact that population is increasing, especially in commercial areas, wherein you can find some establishments that are into business that make their own premises and that of others highly vulnerable to conflagration;

WHEREAS, as we all know that a local fire department takes responsibility not only in fire incidents but likewise takes the lead in responding to all forms of disasters, be it natural or man made;

WHEREAS, what makes this body so confident that the LGU must have a firetruck of its own even thru donation is that, it has presently identified and allocated an ideal and a sizeable area within which a building can be constructed to house the local fire department, its personnel and its facilities;
