WHEREAS, damage to crops, properties and infrastructure projects according to reports coming from the MSWDO, the Municipal Agriculture Office and the MDRRMC, has already reached to millions of pesos in worth;

WHEREAS, not only that because families especially those living in low areas are equally affected as they are now forced to vacate their homes when a large volume of water suddenly surged drowning houses and livestock in 5 or more feet deep muddy waters;

WHEREAS, the most immediate need of the affected people now is the adequate supply of food, water and medicines, hence this declaration of state of calamity in the municipality is very urgent in order to address this most pressing concern, hence;
