RESOLUTION NO. 2012-93

A RESOLUTION GIVING AUTHORITY TO MAYOR LOLITA A. MORAL TO EXTEND FOOD ASSISTANCE TO THE MUNICIPALITY OF NEW BATAAN, COMPOSTELA VALLEY PROVINCE FOR THE VICTIMS OF TYPHOON PABLO.

WHEREAS, a super typhoon they call typhoon Pablo horrendously turned a once progressive town of New Bataan in the Province of Compostela Valley into a graveyard for countless of helpless and missing residents;

WHEREAS, the typhoon claimed not only lives but shattered homes and various structures, impaired limbs and covered vast rice fields and farms with thick mud thereby sending survivors totally incapacitated. Their extremely pathetic situation is evident as the sight of children and women asking for food and donations from passersby in the national highway, while hundreds of families with very young children and elderly packed tight in evacuation centers getting sick is truly heart wrecking, a situation that this locality cannot stand without extending any help;

WHEREAS, this body knew how really bad and sad it feels like being hit by a calamity as Braulio E. Dujali is also a flood prone area. In fact the recent and last year's typhoon Sendong brought damage to the locality. Though the effect was not as severe as New Bataan's (God forbids) but then, it got help from neighboring LGUs and other government agencies, one of which was a financial assistance of One Hundred Thousand pesos (P 100,000.00) from the City of Panabo, that according to the Honorable Mayor Lolita A. Moral, continue to be unspent until this time;

WHEREAS, this body has appreciated the good Mayor of her decision that instead of using the said amount for some flood related projects in the municipality, it will be used in the purchase of food and relief goods for the victims in New Bataan;

WHEREFORE, on motion of Hon. Restie E. Tabirao and duly seconded by Hon. Allan S. Paraguya and Hon. Joelito B. Juriana, it is hereby

RESOLVED TO GIVE AUTHORITY AS THIS BODY HEREBY GIVES AUTHORITY TO MAYOR LOLITA A. MORAL TO EXTEND FOOD ASSISTANCE TO THE MUNICIPALITY OF NEW BATAAN, COMPOSTELA VALLEY PROVINCE FOR THE VICTIMS OF TYPHOON PABLO.

RESOLVED FURTHER, THAT SOURCE OF WHICH SHALL COME FROM THE FINANCIAL ASSISTANCE EXTENDED BY THE CITY OF PANABO IN THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P 100,000.00).
