WHEREAS, the LGU of Braulio E. Dujali makes bank transactions in Land Bank of the Philippines, Panabo City. The only bank that this LGU maintains deposits of its trust, general and other funds;

WHEREAS, LBP is distant from this LGU and it will take one to two hours travel every time the latter transacts business;

WHEREAS, one of the transactions the LGU regularly undertakes that involves huge amount is bank withdrawals of salaries and wages of officials and employees. This activity is indeed very enticing or tempting for lawless elements. The distant between the bank and the LGU offers an opportune time for rascals to carry out their wicked and abominable trade;

WHEREAS, the PERASWELDO Program of the ONB once availed will be the LGU's safest way of transacting business as MTO personnel need not go through tedious and risky withdrawals of salaries, wages and other emoluments due the officials and employees as the bank will only have to issue them individual ATM cards, aside from ATM to be installed in the locality for a safer, convenient and risk free withdrawals;
