**RESOLUTION INDORSING THE EN-TOTO PROCEEDINGS OF THE 7<sup>th</sup> REGULAR SESSION DURING THE QUESTION HOUR OF THE SANGGUNIANG BAYAN OF BRAULIO E. DUJALI, DAVAO DEL NORTE DATED AUGUST 15, 2013 TO THE GRIEVANCE COMMITTEE OF THE LOCAL GOVERNMENT UNIT FOR APPROPRIATE ACTION.**

**WHEREAS**, on the Question Hour of the Sangguniang Bayan's session Mr. Leonardo Taladhay, Jr. appeared to shed light on the alleged utilization of LGU's property (fogging machine with reagents ) at Purok Pag-ibig, Mankilam, Tagum City on July 25, 2013, Thursday;

**WHEREAS**, upon thorough questioning and deliberation the Sangguniang Bayan found out that there was not even a single document that could prove to the validity of his explanation that the withdrawal of our fogging machine from the concerned office was proper and legal;

**WHEREAS**, as per the provisions of **RA 7160** known as **Local Government Code** particularly **Title III, Section 89, paragraph A, number 5 (Prohibited Business and Pecuniary Interest)** that states, *"It shall be unlawful for any local government officials or employees, directly or indirectly, to: Possess or use any public property of the municipality for private purposes"* as well as **RA 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) Section 4, paragraph a** (Commitment to Public Interest) that provides, *"Public officials and employees shall always uphold the public interest over and above personal interest. All government resources and powers of their respective offices must be employed and used efficiently, effectively, honestly and economically particularly to avoid wastage on public funds and resources."*
