MUNICIPAL ORDINANCE NO. 2011 - 137

“AN ORDINANCE REQUIRING ALL GOVERNMENT AND PRIVATE AGENCIES TO PROPERLY SPELL OUT THE OFFICIAL NAME OF THE MUNICIPALITY OF BRAULIO E. DUJALI, IN ALL COMMUNICATION LETTERS, SIGNAGE AND OTHERS.

Be it ordained by the Sangguniang Bayan of Braulio E. Dujali, Davao del Norte in Session Assembled, that:

SECTION 1. DECLARATION OF POLICY. It shall be the policy of the Sangguniang Bayan to require all government and private agencies in the Municipality of Braulio E. Dujali to properly spell out the official name of the municipality in all communication letters, signage and others subject to some provisions as provided in this ordinance.

SECTION 2. DEFINITION OF TERMS. As used in this ordinance, the following terminologies are defined:

- a.) **LETTERS** – refers to the characters representing one or more of the sounds used in speech.
- b.) **SIGNAGE** –is any kind of visual graphics created to display information to a particular audience.
- c.) **COMMUNICATION** – is the activity of conveying meaningful information.
- d.) **SPELL OUT** – To name or write in order the letters that constitute (a word or part of a word)

SECTION 3. PENALTY CLAUSE. Any communication letters, signage and other printed information materials shall not be considered legal and official if they bear not the official name of the municipality. If it pertains to requests addressed to the Executive or Legislative departments, shall not be given appropriate action.

SECTION 4. REPEALING CLAUSE. Any ordinance, office order or other issuances of the previous Executive Department that are not in consonance to this ordinance shall be repealed or amended accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately after its approval.
