MUNICIPAL ORDINANCE NO. 2010-126

AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 31 SERIES OF 2000, OTHERWISE KNOWN AS, "AS ORDINANCE ESTABLISHING THE TEMPORARY TERMINAL FOR ALL PUBLIC UTILITY VEHICLES OPERATING IN THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, AND PRESCRIBING TERMINAL FEE THEREOF".

Be it enacted by the Sagguniang Bayan that:

SECTION 1. Section 1 of Municipal Ordinance No. 31 series of 2000 shall be amended and to be read as follows "The temporary terminal shall be situated inside the government center at the vacant portion fronting the municipal gymnasium beside the temporary public market for the purpose of accommodating in an orderly manner, all public utility vehicles soliciting passengers in the locality and there shall be also prescribed appropriate terminal fee thereof".

SECTION 2. Section 3 of the same ordinance shall likewise be amended to be read as follows " a. Public Utility Jeeps b. Multicabs C. Public Utility Buses".

SECTION 3. Section 4 of the same ordinance shall also be amended to be read as follows " Regardless of route and frequency of trips, every public utility vehicle specified in Section 3 shall pay a terminal fee in the amount of EIGHT PESOS (P8.00) per trip by any personnel of the Municipal Treasurer's Office designated for the purpose who shall likewise issue cash tickets to drivers or operators".

SECTION 4. The same ordinance shall furthermore be amended by adding another provision to fall under Section 5 which shall be read as follows "Loading and unloading of passengers after 5:00 P.M. shall be allowed outside the government center".

SECTION 5. That due to new provision added, Section 5 and 6 of the same ordinance shall now be known as Section 6 and 7 respectively.

SECTION 6. Other provisions of the said ordinance not herein amended shall continue be in full force and effect.

SECTION 7. This ordinance shall take effect upon approval.
