AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE, TO FUND THE VARIOUS PROJECTS IN THE AMOUNT OF FORTY ONE MILLION THREE HUNDRED FIFTY THOUSAND PESOS (P41,350,000.00).

BE IT ORDAINED by the Sangguniang Bayan of Braulio E. Dujali, Province of Davao del Norte that:

SECTION 1. The Municipality of Braulio E. Dujali, represented by **Atty. Leah Marie A. Moral-Romano**, Municipal Mayor, is hereby authorized to enter into a loan agreement with the Land Bank of the Philippines, in accordance with Section 297 of the Republic Act No. 7160 otherwise known as the Local Government Code of 1991, in the amount of **FORTY ONE MILLION THREE HUNDRED FIFTY THOUSAND PESOS (P41,350,000.00)**, under the terms and conditions set forth therein, and subject to the requirements stated under Section 123 of Republic Act No. 7653, as implemented by the Bangko Sentral ng Pilipinas Circular No. 402;

SECTION 2. The Municipal Mayor shall have the authority to represent the Municipality of Braulio E. Dujali by signing, executing and delivering such agreements, contracts, deeds and

other related documents pertaining to the borrowing that are deemed necessary and proper for the full implementation of intended priority projects.

SECTION 3. VARIOUS PROJECTS referred hereto as priority projects are included in the LGU's Annual Investment Plan for CY 2017 and 2018.

Section 4. The Municipality hereby appropriates the entire proceeds of the borrowing exclusively to finance the following:

A) ACQUISITION OF HEAVY EQUIPMENT:

- 1 unit Long Reach Backhoe
- 1 unit Grader
- 1 unit 10-Wheeler Dump Truck
- 1 unit 6-Wheeler Dump Truck

B) ACQUISITION OF TWO (2) UNITS SUPPORT VEHICLE

C) ACQUISITION OF FIVE (5) UNITS AMBULANCE (MULTICAB)

CARRIED UNANIMOUSLY.


