A RESOLUTION AMENDING SB RESOLUTION NO. 2016-186 THAT INSTEAD OF UTILIZING THE PCF SUBSIDY AMOUNTING TO P3,000,000.00 TO TWO (2) PROJECTS NAMELY, COMPLETION OF MUNICIPAL PUBLIC TERMINAL AND ACQUISITION OF RESCUE EQUIPMENT (MINI-DUMPTRUCK) IT WILL BE SOLELY UTILIZED FOR PURCHASE OF ONE (1) UNIT RESCUE EQUIPMENT (DUMPTRUCK)

WHEREAS, the Municipality of Braulio E. Dujali is a recipient of the Department of Interior and Local Government's (DILG) Performance Challenge Fund (PCF) amounting to Three Million Pesos (P3,000, 000.00);

WHEREAS, the Sangguniang Bayan of this municipality had adopted a resolution dated December 5, 2016 embodying the following:

"A resolution authorizing the Municipal Mayor, Hon. Leah Marie Moral-Romano representing the Local Government Unit of Braulio E. Dujali to enter into Memorandum of Agreement with the Department of Interior and Local Government-Regional Office No. XI represented by its Regional Director, Ananias M. Villacorta, CESO III for the implementation of the Performance Challenge Fund (PCF) in the amount of Three Million Pesos (P3,000,000.00) for the Completion of Municipal Public Terminal and Acquisition of One (1) Unit Rescue Equipment (Mini-Dumptruck) of the Municipality of Braulio E. Dujali and certifying that said projects are listed in the CY 2016-2020 Local Development Investment Plan (LDIP) of this municipality"

WHEREAS, the DILG issued a Memorandum Circular No. 2016-167 dated November 23, 2016 which was recently received by the Local Chief Executive which paragraph 5.1.2.4 states that "Proposed project must be a whole single project and not a component of other projects";


WHEREAS, in compliance with the said memorandum, it is necessary to amend the SB Resolution No. 2016-186;
