APPROVING MDC RESOLUTION NO. 10 CY 2017 OTHERWISE KNOWN AS, "A RESOLUTION REQUESTING THE SANGGUNIANG BAYAN, THIS MUNICIPALITY TO PASS AN ORDINANCE AUTHORIZING THE PROPOSED BORROWINGS OF THE MUNICIPALITY OF BRAULIO E. DUJALI, DAVAO DEL NORTE AMOUNTING TO THIRTY SEVEN MILLION PESOS (PHP 37,000,000.00) FROM THE LAND BANK OF THE PHILIPPINES (LBP), TAGUM CITY BRANCH.

WHEREAS, MDC Resolution No. 10 CY requesting the Sangguniang Bayan, this municipality to pass an ordinance authorizing the proposed borrowings of the municipality of Braulio E. Dujali, Davao del Norte amounting to Thirty Seven Million Pesos (37,000,000.00) from the Land Bank of the Philippines (LBP), Tagum City Branch, was received by this honorable council for immediate and appropriate action;

WHEREAS, said resolution expresses the desire to apply for a loan from the Land Bank of the Philippines, Tagum City Branch amounting to Thirty Seven Million Pesos (P37,000,00.00);


