REQUESTING POLICE SENIOR INSPECTOR JAY B NOCIDAL, CHIEF OF BRAULIO E. DUJALI POLICE STATION, BRAULIO E. DUJALI, DAVAO DEL NORTE, TO BE PRESENT DURING THE 31ST REGULAR SESSION OF THE SANGGUNIANG BAYAN ON AUGUST 14, 2017, IN ORDER TO GIVE UPDATES ON THE PEACE AND ORDER OF THIS MUNICIPALITY.

WHEREAS, the present armed conflict in Marawi City has prompted President Rodrigo Roa Duterte to place the entire Mindanao under martial law and recently, the Congress has approved his request for its extension until December 31, 2017;

WHEREAS, this move of the President had ultimately prevented the chaos to also take place in other localities especially the adjoining local government units. However, government officials and ordinary people cannot disregard the possibility of terrorists who are able to make their way out of the war-torn city to hide their real identities in order to mingle with groups of evacuees who are given shelters in Cagayan, Iligan. Some of them have been suspected to have gained entry to other places undetected;

WHEREAS, this honorable body is concerned not just by the threat that terrorists can do outside Marawi City. The rampant illegal drug trade/use in the country is equally threatening and has to be addressed drastically. It is for this reason that this honorable body wants to get updates on the real situation of this locality and some important information on how well local police have fared in the government's campaign against illegal drugs and criminalities. These can also lead


to identifying and implementing measures in support to authorities' effort in preserving peace and order in this locality;

WHEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by all members present, it is hereby


