WHEREAS, after a thorough deliberation on the matter presented, this body on unanimous accord moved to confirm the same, it having complied all existing rules, laws and regulations;


WHEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by all members present, it is hereby;




