DISAPPROVING THE REQUEST AS PER RESOLUTION NO. 20 SERIES 2017 OF BARANGAY TANGLAW, THIS MUNICIPALITY FOR THE ISSUANCE OF SPECIAL PERMIT FOR THE HOLDING OF COCKFIGHT ON SEPTEMBER 2, 3 AND 4, 2017

WHEREAS, Resolution No. 20 series 2017 of Barangay Tanglaw, this municipality was brought to the attention of this august body and the same was endorsed to the Committee on Ways and Means for study;

WHEREAS, during the committee hearing conducted for the said purpose, the following findings were noted:

1. Resolution No. 20 series of 2017 of Barangay Tanglaw requesting for issuance of a Special Permit for the holding of cockfight was submitted beyond the date prescribed in in Section 9 (5) and the proceeds of the cockfight was not mentioned in the resolution which is in conflict with Section 9 (3) of the revised cockfighting code of this municipality.
2. Holding of cockfight shall only be allowed during Sundays, Legal holidays and Local fiestas, however their request is in connection with the celebration of Araw ng Tanglaw which is contrary to Section 8 (H) of the abovementioned code.



WHEREFORE, on motion of Hon. Yasmin V. Campion and duly seconded by Hon. Angelito P. Orillosa, it is hereby;


