ADOPTING THE AGRARIAN REFORM COMMUNITY CLUSTER 2 (ARC CLUSTER 2) DEVELOPMENT PLAN OF THE PROVINCE OF DAVAO DEL NORTE AND EXPRESSING THE COMMITMENTS AND UNDERTAKINGS OF THE MUNICIPLITY OF BRAULIO E. DUJALI IN THE IMPLEMENTATION OF THE DEVELOPMENT PLAN.

WHEREAS, the Department of Agrarian Reform (DAR) launched Agrarian Reform Communities (ARCs) In 1993 as a department strategy to rationalize and hasten the delivery of the basic support requirements of the Agrarian Reform Beneficiaries (ARBs);

WHEREAS, in order to intensify rural development in ARCs, the Department of Agrarian Reform (DAR) had issued Memorandum Circular No. 3 of 2006, promoting connectivity among the ARCs and other CARP areas, which aims to further extend the geographic reach of the ARCs to cover a greater number of ARBs and other farmers in adjacent barangays and need to fast-track the delivery of the needed basic support services.

WHEREAS, to establish the connectivity strategy, clustering of the ARC municipalities was implemented covering the municipalities of Sto. Tomas, Braulio E. Dujali, Carmen and Panabo City, all in the District 2 of the Province of Davao del Norte and aptly formed as Agrarian Reform Communities Cluster 2 or ARC Cluster 2.

WHEREAS, a member of the Area Planning Team of this municipality presented before this body the ARC Cluster 2 Development Plan for information and adoption;

WHEREAS, the ARC Cluster 2 Development Plan to be undertaken is in line with the municipality's development plan that is geared towards the realization of the town's vision and mission and this body thereby expresses to give its full support and commitment for the implementation of the development plan and likewise proposes for the integration in the ARC Plan of projects found in the Annual Investment Program for 2018 of this municipality, the same hereunder enumerated in order to ascertain a better quality of life among beneficiaries, to wit:

- 1) Construction of Farm to Market Road at Lot 4013, Purok 5, Cabayanan to Lot 3972, Purok 6, Sitio Anipolo, Cabayanan, Braulio E. Dujali;
- 2) Construction of Farm to Market Road at Lot 3889, Purok Pag-asa, Easty to Lot 3822, Purok Mahayahay, Cabayanan, Braulio E. Dujali ;
- 3) Construction of Farm to Market Road at Lot 3651, Purok 3-A (Gayatin property) to Lot 3628, Purok 1-B, Barangay Cabayanan, Braulio E. Dujali;


WHEREFORE, on motion of Hon. Nelson C. Baer and all members present voted in favor, it is hereby




